

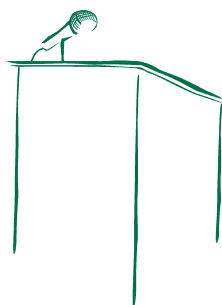

INTERACTIVE GAMING

The 270-day clock is running on drafting regulations that implement the money transfer restrictions imposed on the financial transaction sector pursuant to the Safe Port Act. As with any new piece of legislation, the devil is in the details. What is the bottom line impact of the Safe Port Act on Internet gaming activities in the United States? In addition, what opportunities are presented by the intrastate exemption contained in the Safe Port Act? Does this open the door to intrastate Internet gaming in Nevada? Can Nevada team up with other states that permit intrastate Internet gaming, thereby creating a form of interstate Internet gaming? The panel will address these questions and a host of other issues raised by the Safe Port Act's financial transaction restrictions aimed at the Internet gaming industry.
